For engineering applicants, all academic examinations will be offered at this session.

For geoscience applicants, please request the examination you wish to write on the attached Examination Application.

The examinations will be held at the centres shown on the attached Examination Application, or at any other suitable test centre. A suitable invigilator (professional engineer or professional geoscientist) must be nominated to invigilate examinations at other test centres selected. Candidates will be responsible for all expenses that may incur if examinations are written outside Canada. All candidates who intend to write examinations at the next examination session must complete the Examination Application and return it to this office no later than **Friday, August 19, 2011**, together with the examination fee for each paper to be written.

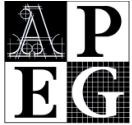
A **change fee** will be charged for each change made by the applicant after the examination application deadline, if they wish to write at a session other than the one originally applied for. The change fee amount can be found on our website at <http://www.apeg.bc.ca/reg/fees.html>

Candidates will receive a detailed timetable and examination format approximately 3 weeks prior to examination date. Candidates who have applied to write examinations and who do not attempt these examinations will receive a mark of **zero**.

Please note that due to a policy change, **penalty exams** are waived as of September 7, 2007. This policy change applies to **Confirmatory Examinations only**. If you are writing confirmatory exams, have failed a previous exam, and were assigned an additional penalty exam, please consider this exam as being waived.
